## For filling out the contact form

The protection of the data you provide is extremely important to us, and we handle the personal data sent to us through the contact form with adequate protection.

The data provided when filling out the contact form is managed by Kentaur Graphics (hereinafter referred to as the Data Controller). The Data Manager assumes no responsibility for the veracity and authenticity of the data provided by the user (hereinafter referred to as the User) through the contact form.

Since filling out the contact form is also available to companies with legal personality and other legal entities, the data of these organizations (company name, contact information) are not considered personal data in accordance with the GDPR, as data not relating to natural persons.

### Legislation related to data management

The data manager applies the following legal regulations in force during data management: Regulation 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and the free flow of such data, as well as the repeal of Regulation 95/46/EC (General Data Protection Regulation).

CXII of 2011. Act on the right to self-determination of information and freedom of information (Infotv.).

XLVIII of 2008. Act on the basic conditions and certain limitations of economic advertising activity (Grt.).

CVIII of 2001. Act on certain issues of electronic commercial services and services related to the information society (Ekertv.).

CXIX of 1995. Act on the management of name and address data for the purpose of research and direct business acquisition (Kkt.).

### Purpose and legal basis of data management

Through the contact form, the User has the opportunity to contact the data controller or send him a message electronically. Contact with the User is made in the reply message to the submitted message, or by telephone upon request. The data manager does not use the User's personal data for no other purpose than the specified.

Data management is carried out with the User's voluntary consent. Consent is confirmed on the kentaurgraphics.hu website, when filling out the contact form, by reading and accepting this information.

The User is not obliged to provide his/her personal data, however, in the absence of these, or in the case of wrongly provided data, proper contact with the User may fail.

The managed data

To send a message via the contact form, you need to enter the following personal data: name, e-mail address, phone number.

Duration of data management

The data manager processes the contact information provided by the User for one year from the date of request.

The rights of the data subjects in relation to the processing of the provided personal data

The User should receive clear and transparent information regarding data management and the deletion of personal data provided. At the request of the User, the personal data is restricted by the data manager.

Deletion of personal data

The data manager deletes the User's personal data if he withdraws his consent. The data controller shall delete the User's personal data within 15 days at the User's request. The data controller deletes the User's personal data if the National Data Protection and Freedom of Information Authority or the court requests the deletion of the Data Subject's personal data. The data is deleted according to the provisions of the final decision or order.

Limitation of Liability in relation to data management

The data manager does not check the personal data provided to him. The person providing it is solely responsible for the veracity of the personal data provided.
